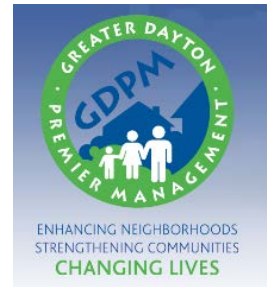
This event will give attendees:
